BURST AWAY showed speed from the outset, stayed out from the rail once clear midway on the backstretch and continued gamely between the top two. SMOKY OPAL lagged following a slow break, raced two wide between rivals around the turn and gained slowly through the lane. SPEEDWAY MONKEY was in hand early, was sent up wide on the turn and gained mildly through the lane. SHE'S ALL TIMBER wasn't far back inside early, came out three wide on the turn then weakened. AMERICAN PLACED was wide and outrun.
