#### Footnotes

LUNAR ROCK secured the rail soon after the break and disputed the pace inside of WHO DAT BOY, was patiently handled allowing that rival to go on a bit past the three quarter pole, re-bid within himself to take command nearing the half mile marker, dueled under rating to the quarter pole, spurted clear when asked entering the lane, kept on under stout left handed rousing and lasted. NO BRAKES rated in a good position into the backstretch, edged up between runners nearing the far turn, dropped to the rail and crept closer after six furlongs, eased off the inside for the final furlong, closed gamely and was getting to the winner. REGAL WARRIOR broke a step slow, was sent up between foes soon after and gained a stalking spot three wide, came under pressure chasing past the five sixteenths pole, stayed in range to mid stretch then flattened out. OUTHAUL was taken well in hand soon after the break and angled wide for the backstretch run, progressed four wide leaving the three eighths pole, pursued into the stretch but came up empty in the final furlong. WHO DAT BOY vied outside the winner, edged away a bit past the three quarter pole, was re-engaged after a half mile, battled to the quarter pole then retreated. COUNT TO SEVEN saved ground and faded. TOOTH N CLAW settled off the pace while saving ground, angled out for the run around the final turn, was under a hard drive four wide entering the stretch but failed to make an impact. LAGI LAGI saved ground, raced in range to the far turn then faltered. SHORDAWATYADRINK, taken wide early, faltered leaving the far turn and stumbled when being eased late.
