IN MY IMAGINATION stayed out from the inside while unhurried then made up ground belatedly. FAVORITE PATRIOT wasn't far back along the inside early, swung wide into the stretch and lacked a closing. SLEEPING TIGER lagged inside to the stretch then gained too late. NAVY CROSS wasn't far back outside early, stayed well out from the inside around the turn and tired.
